ROCKY MOUNTAIN ELK FOUNDATION CONVENTION DONATION POLICY HUNT AND TRIP

1. **FULL DONATION:** The Rocky Mountain Elk Foundation will retain 100% of the proceeds from a donated item.
2. **SPLIT DONATION:** A donation is eligible for a split return if the **value** of the individual donation is **more than \$2,500**. The split return amount will be based on the final auction sale price as outlined below.
3. **FOREIGN HUNT OR TRIP SPLIT DONATION:** If the donation is a foreign hunt or trip, the value of the individual donation must be more than \$8,000 to qualify for a split and the maximum return is 30%.
4. A hunt donor must be an **approved RMEF Outfitter Member** in order to donate a big game hunt.

NOTES:

1. All donations must be approved by the Donations Manager.
2. RMEF reserves the right to accept or decline donations and to use donations at any Rocky Mountain Elk Foundation function.
3. **Any split return payment will be made to the donor within 4 - 6 weeks following the convention.**
4. Donations become property of RMEF upon acceptance by RMEF.
5. If RMEF issues a refund to the auction hunt/trip buyer, the outfitter must return the split return payment, if any, that he/she received for the donation and any other costs incurred by RMEF.
6. If an outfitter sells his/her business after the donation is auctioned, it is the responsibility of the outfitter to inform the new owner of any outstanding donations and insure that the commitments to the auction buyer are kept.
7. This donation may not be donated or transferred to another party without written permission from the donor/outfitter.
