OFFICIAL RULES

Ensure that your name and correct address appear on every entry ticket you return. Mail-in entries must be postmarked by June 1, 2023, and received by June 7, 2023. Non-conforming entries will be disqualified. Regardless of entry method, there is a limit of forty-eight (48) sweepstakes entries per person/email during the entire Entry Period.
