Those utilizing the Free Method of Entry are limited to five (5) entries per day during the Entry Period. There is a limit of fifty (50) total entries allowed per person/email address, regardless of the combination of entry method(s) used, and attempted entries in excess of this limit will be disqualified, and all entries from any person making such attempt will be voided.
