

## OFFICIAL RULES

### **NO PURCHASE NECESSARY TO ENTER OR WIN. ALTERNATIVE ENTRY METHOD PROVIDED.**

### **A PURCHASE OR PAYMENT OF ANY KIND WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

The following 2024 NFR & Horse Trailer Package (the “Drawing”) is open to legal residents of the 50 states of the United States of America and the District of Columbia, (the “USA”) only, excluding Florida, New York, and Rhode Island. Any entries received from outside of the USA will not be considered in the Drawing. The Drawing is subject to all federal, state, and local laws and regulations. **Void in other countries, U.S. territories, and where prohibited or restricted by law.**

**Eligibility Requirements (age, geographic restrictions, residence, occupation; exclusions to eligibility):** The Drawing is open and offered only to legal residents of the USA who are at least 21 years of age at the time of entry. Employees of Rocky Mountain Elk Foundation, Palms Casino Resort and National Trail Source, together with their immediate families (parent, child, sibling, or spouse) and/or household members, and any other persons or entities associated with this promotion, are not eligible to participate.

**Sponsor:** The Drawing is sponsored and administered by the Rocky Mountain Elk Foundation (“RMEF”), 5705 Grant Creek Road, P.O. Box 8249, Missoula MT 59807-8249.

**How to Enter:** Entries for Drawing begin at 12:00:01 a.m. Eastern Standard Time (“EST”) on December 7, 2023, and ends 11:59:59 p.m. EST on December 16, 2023. RMEF’s computer is the official time-keeping device for the Drawing.  
**Limit one (1) per person.** Method of entry:

- 1) **On RMEF’s website:** Eligible entrants can follow the link on RMEF’s page and fill out the form provided.

All entries become the exclusive property of RMEF and will not be acknowledged or returned. Any entry that is deemed incomplete, illegible, fraudulent, or corrupted, in RMEF’s sole discretion, is void and will not be accepted.

**Drawing and Notification:** Drawing winners will be selected at random from among all eligible entries received by RMEF, whose decisions are final and binding. Prize drawings will be conducted on or about December 16, 2023. The potential Prize Winners will be notified by telephone (a message will not be left), and/or by email. If a Drawing winner cannot be contacted within three (3) days after the first attempt to contact him/her, RMEF may select an alternate Drawing winner at random from the remaining entries. After initial contact, the Drawing winner and RMEF will determine method of prize delivery.
