Void in the state of Washington and where prohibited or restricted by law. Subject to all applicable federal and state and local laws and regulations. Online entries must be received during the Entry Period. Box 8249, Missoula, MT 59807. Mail-in entries must be postmarked by August 31, 2024, and received by September 7, 2024. Non-conforming entries will be disqualified. Regardless of entry method, there is a limit of fifty (50) sweepstakes entries per person per day and one hundred fifty (150) sweepstakes entries per person/email during the entire Entry Period. Any attempt to exceed this limit may automatically disqualify all entries from that entrant. Entry materials/data that have been tampered with or altered will be disqualified.
