# 2025 HIGH-5 DREAM HUNT SWEEPSTAKES

## OFFICIAL RULES

- 1. NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

Void in Washington, U.S. territories and where prohibited or restricted by law. Subject to all applicable federal, state and local laws and regulations. Box 8249, Missoula, MT 59807. Mail-in entries must be postmarked by May 20, 2025, and received by May 27, 2025. Non-conforming entries will be disqualified. Regardless of entry method, there is a limit of three-hundred-fifty (350) sweepstakes entries per person/email address during the entire Entry Period and a maximum of 100 entries per day. Any attempt to exceed this limit may automatically disqualify all entries from that entrant. Entry materials/data that have been tampered with or altered will be disqualified.
