OFFICIAL RULES**

**NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.**

**A PURCHASE OR DONATION WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**The NFR 2022 Las Vegas Getaway Sweepstakes (“Sweepstakes”) begins at 12:00 AM Eastern Time (“ET”) on 3/11/22 & ends at 11:59 PM ET on 11/1/22 (“Entry Period”).**

**1. Eligibility:** Open to legal residents of the 50 United States & the District of Columbia, age 21 years or older at time of entry. Subject to all applicable federal & state & local laws & regulations. Void where prohibited by law. Employees & their immediate families (parents, children, spouse, siblings) of the Rocky Mountain Elk Foundation (“RMEF”) (“the Sponsor”), prize providers & their respective parent companies, affiliates, subsidiaries, sales representatives &/or distributors, & their immediate families, advertising & promotion agencies involved in this Sweepstakes & those living in the same household (whether related or not) are not eligible to enter.

**3. CONSUMER DISCLOSURES:** No purchase necessary. You have not yet won. Ends 11/1/22. One (1) Grand Prize winner will be drawn. Grand Prize: A trip for winner and guest to Las Vegas to attend the National Finals Rodeo 2022 event. Travel is tentatively scheduled on 12/7/22 to 12/10/22. Trip consists of: 4 day/3 night double occupancy accommodations at Virgin Hotels Las Vegas (in Ruby Tower, with dedicated check-in and valet parking); \$500 Dining and Beverage Credit to be used at Virgin Hotels Las Vegas restaurants including Todd English's Olives, Kassi Beach House, Casa Calavera, Night + Market, Bar at Commons Club and The Shag Room; roundtrip coach air transportation for winner and guest to Las Vegas, NV; and tickets for two to 3 nightly performances of the 2022 National Finals Rodeo. Total approximate retail value: \$4,800.

All applicable taxes, baggage fees, travel or medical insurance, gratuities, other incidental expenses not mentioned herein are not included. Actual value of each trip prize depends on location of winner, airfare and accommodation at time of booking. If actual value of prize is less than the stated ARV, the difference will not be awarded.
