**ELIGIBILITY:** The following RMEF “Win a Hunt with Randy Newberg” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the 50 states of the United States of America and the District of Columbia, (the “USA”) who are at least 21 years of age at time of entry. \*Note: Winner will join the hunt as a companion/partner of, and not as a client/customer of, Randy Newberg. Randy Newberg is not a hunting guide and this is not a professionally guided hunt. No part of the VRV for this prize is for guiding or outfitting services.

**CHANCES OF WINNING A PRIZE:** Odds of winning the prize depend on the number of entries received. One (1) winning entry will be drawn at random from a pool of all valid entries received.

**DRAWING:** The potential Prize winner will be selected in a random drawing from among all eligible entries. Prize drawing will be conducted by a representative from RMEF on or about 11/14/22. There will be one (1) Prize awarded following the conclusion of the Sweepstakes period. The potential Prize winner will be determined by drawing a winning entry at random from all valid entries.
